## **Manufactured Home Statement**

A \$25.00 moving permit shall be purchased, and the replaced home shall be removed from the lot within 14 days of the new home installation.

All M/Hs being located on Waterfront Lots within the Performance Zone shall be "double wide" units and shall not be older than <u>five (5) years of age</u>. All MHs being located on Second Row Lots within the Performance Zone shall not be older than <u>ten (10) years of age</u>. All MHs located in the Performance Zone in areas that are not classified as Waterfront Lots or Second Row Lots shall not be older than <u>thirty (30) years of age</u>.

I understand that it is illegal to move any mobile home from any site, or to install a mobile home on any site, without a mobile home setup permit from the Planning Department. No building, or other structure, shall be erected, nor shall any existing building or other structure be moved, added to, enlarged, or structurally altered before the issuance of a Building Permit. To obtain a Building Permit, you will be required to submit a set of drafted plans. Fees will be double when work has been started prior to the purchase of a building permit.

I understand all mobile homes must meet the County's setback, underpinning and steps requirements prior to getting power connected. I understand it is illegal to move any mobile home older than 30 years old <u>into</u> the County, however any mobile home may be moved to property <u>within</u> the County upon satisfactory proof the unit is currently on the County tax rolls. This does not apply to Waterfront Lots, or Second Row Lots located in the Performance Zone. I hereby certify that I have carefully read this application and that the information provided above is true and accurate to the best of my knowledge.
