AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT BETWEEN CLARENDON COUNTY, SOUTH CAROLINA, TIM BAXLEY, SHERIFF OF CLARENDON COUNTY AND THE TOWN OF TURBEVILLE, SOUTH CAROLINA FOR THE PROVISION OF LAW ENFORCEMENT SERVICES BY THE CLARENDON COUNTY SHERIFF'S OFFICE WITHIN THE TOWN OF TURBEVILLE, SOUTH CAROLINA AND OTHER RELATED MATTERS THERETO.

WHEREAS, the Town of Turbeville, South Carolina ("Turbeville") has identified a need for the Clarendon County Sheriff's Office ("CCSO") to provide law enforcement services within the town limits of the Turbeville;

WHEREAS, Turbeville has met with representatives from CCSO and Clarendon County ("County") to discuss the terms and conditions surrounding this service;

WHEREAS, an Intergovernmental Agreement ("Agreement") has been prepared and reviewed by Turbeville, Sheriff and County. Agreement is attached hereto as Exhibit A;

WHEREAS, on December 10, 2019, at a duly called and noticed meeting of Turbeville, it approved and accepted Agreement and requests County do same; and

## NOW THEREFORE, CLARENDON COUNTY COUNCIL RESOLVES:

- Section 1. The Agreement mentioned herein and attached hereto as Exhibit A is approved.
- Section 2. The Clarendon County Administrator (and his/her designated appointee(s)) is authorized and directed, in the name of and on behalf of County, to execute Agreement and take whatever further actions and execute whatever further documents as the County Administrator (and his/her designated appointee(s)) deems to be reasonably necessary and prudent to affect the intent of this Resolution.
- Section 3. Clarendon County Council acknowledges CCSO's intent to assist with the provision of law enforcement services in Turbeville and supports its intent to do same.
- Section 4. The Clarendon County Administrator (and his/her designated appointee(s)) is authorized and directed to create and fund positions as the County Administrator (and his/her designated appointee(s)) deem reasonably necessary to meet the obligations of Agreement.
- Section 5. Any resolution or other order of Clarendon County Council, the terms of which are in conflict with this Resolution, is, only to the extent of that conflict, repealed.
  - Section 6. This Resolution is effective immediately after its adoption.
