A RESOLUTION OF  
CLARENDON COUNTY, SOUTH CAROLINA

**AUTHORIZING RECEIPT, ACCEPTANCE, AND EXPENDITURE OF FUNDS UNDER THE AMERICAN RESCUE PLAN ACT OF 2021 (ARPA); AND RELATED MATTERS.**

**THE CLARENDON COUNTY, SOUTH CAROLINA, COUNTY COUNCIL RESOLVES:**

**SECTION 1. Findings.**

WHEREAS, the County is a political subdivision of the State of South Carolina (“State”) and possesses all powers granted to political subdivisions by the Constitution and general laws of the State;

WHEREAS, the County anticipates receiving approximately \$6,554,571 in one or more payments (collectively, “Funds”) from the United States Treasury as a result of the ARPA; and

WHEREAS, the County Council desires to authorize various officials to receive, accept, and expend the Funds.

**SECTION 2. Authorization.** The County Council authorizes (a) the County Treasurer to receive and hold the Funds on behalf of and for the benefit of the County, and (b) the County Administrator, the Deputy County Administrator, and the Chief Financial Officer, and each of their designee(s) to accept the Funds on behalf of the County and expend the Funds according to the proposed project list, attached hereto and incorporated herein by reference, and otherwise, as the County Administrator deems just and proper, all without further action required of the County Council.


**SECTION 3. Further Authorization.** The County Council authorizes the County Administrator, the Deputy County Administrator, and the Chief Financial Officer, acting jointly or individually, to take whatever actions, including interacting with other elected officials, and execute and deliver whatever documents as are necessary to implement this Resolution’s intent.

**SECTION 4. General Repealer.** Each resolution, or order of County Council, or any part of the same in conflict with this Resolution, is, to the extent of that conflict, repealed.

**American Rescue Plan Act of 2021 (ARPA)**  
**State and Local Recovery Funds**  
**Clarendon County**

**Proposed Use of Funds:**

**Reimbursement of County Incurred Expenses**

- County vaccination program
- Unreimbursed PPE purchases
- Federal grant administrative expense reimbursement

**Infrastructure Improvements**

- Decommission the County's wastewater treatment facility and route effluent to municipal treatment facility.
  
- Extend County water system from Patriot Road well site to connect to the Wyboo Point water system.
  
- Appropriations to Town of Summerton, City of Manning and Town of Turbeville for water system related projects (\$150,000 each)
  
- Improvements to the primary ground storage tank (allowing it to support larger system mains)
  
- Expansion and renovations to County water system field office
  
- Backup generators (and switches) for water system wells at Patriot Road and Mockingbird Lane
  
- Appropriation to BDC for water/wastewater improvements to industrial park(s)

**Community Health and Safety**

- Two (2) new ambulances, fully equipped
  
- Expand Fire Rescue Community Paramedic program to add additional paramedic, an equipped vehicle and equipment for two (2) years
  
- Appropriation to McLeod Health Clarendon for needed equipment
  - Portable x-ray machine
  - Arterial ultrasound machine
  
- Acquisition of thirty (30) additional 800 mhz radios for Fire Rescure

**Community Education and Support**

- Appropriation to F. E. Dubose Vocational School for the development and implementation job training program(s)
  
- Community Grants program. Grant applications from area non-profit organizations to be awarded based on need and deliverables to respond to the public health emergency with respect to the pandemic and/or its negative economic impact to the community
