Chairman Stewart called the Budget Workshop to order at 6:00 pm. Councilman Richardson led the invocation. The Pledge of Allegiance was recited in unison.

1. Approval of the Agenda

On motion by Councilman Richrdson and Seconded by Councilman Coker Council voted Unanimous Approval to the Agenda for April 29, 2024.

2. Presentation – Mr. Lynden Anthony, County Administrator

Chairman Stewart gave comments on how the budget gets money to operation.

Mr. Anthony began his presentation by thanking County Council for the opportunity to present the budget requests to Council and the citizens of Clarendon County.

He stated that the budget deficit came down \$200,000 from first reading but still has a deficit of \$837,170 as it stands today. He continued by stating that in this budget is a \$100,000 Local Option Sales Taxes Credit to be given back to taxpayers. The numbers will continue to change. Fire Rescue has a 2 million dollars increase, and EMS collections are the same as last year and also the Library has a zero-millage increase.

Mr. Anthony stated that health insurance will have a 11.8% increase as of January 1, 2025 and the 1% increase in employer portion of retirement expense to the State, as well as the 1.6% salary step increase.

Mr. Anthony stated that he would like to go through the Budget book by department. He stated that the department increases are the effect of salary and salary related increases like step increase and health insurance increases.

General Fund Revenue

The General Fund budget before you, reflects a zero increase in millage rate. We are assuming that we will experience continued growth in overall assessed values due to continued growth with vehicles and watercraft at a lower 2% assessed value growth.

Our collection of Local Option Sales Tax continues to grow; we are recommending that the LOST credit be given back to our taxpayers.

The Library Special Tax District, we have prepared a balanced budget with zero growth in millage rate.

Chairman Stewart asked if Council had any questions about the budget. He gave closing comments on the budget workshop. He stated that the value of a mil in Greenville is 1.3 million dollars verses Clarendon County value of a mil is 126,000 and we have to buy the same fire truck and equipment as larger counties. Chairman Stewart concluded his comments by asking Lynden Anthony to bring back a balance budget.

3. Adjourn

Chairman Stewart stated that we have exhausted our agenda and he asked for a motion to adjourn the Special Called Meeting.

On motion by Councilman Richardson and Seconded by Councilman Coker, Council voted Unanimous Approval to adjourn the Special Called Council Meeting – Budget Workshop.

The Budget Workshop adjourned at 7:08 pm.
