Procedures for Tax Sale are found in Title 12, Chapter 51 of the 1976 Code of Laws of South Carolina, as amended.

REDEMPTION period for real estate and mobile homes sold is TWELVE (12) months from the date of sale. Purchaser to pay for all fees and costs associated with the transfer of deed/title if the property is not redeemed.

In accordance with the laws of South Carolina, all Tax Sale mobile homes will be subject to a monthly rent fee before redeeming the home.
